



# ACKNOWLEDGMENT • RELEASE • INDEMNITY • AUTHORIZATION

IN CONSIDERATION of being permitted to enter the facility operated by 1524 Rollins, LLC, a California Limited Liability Company, doing business as the Burlingame Sport Center (“BSC”), and permitted to use the BSC facilities, participate in its supervised and unsupervised activities and services as a player or spectator, and/or enroll the minor, \_\_\_\_\_, (“Participant”) at BSC to participate in the program(s) therein offered, I, \_\_\_\_\_, (“Parent/Guardian of Participant”), do understand and agree as follows:

1. Parent/Guardian, individually, and on behalf of the Participant, freely and voluntarily acknowledges that the use of the facilities at BSC, its supervised and/or unsupervised activities and services, equipment or premises, whether as a spectator or participant, naturally involves the risk of injury to yourself, your guest, the Participant, and/or property, whether caused by you, another participant, or someone else at the facility including, but not limited to, BSC. Parent/Guardian represents and warrants that Participant is in good health and physical condition and has no disability, illness, or other condition that could prevent Participant from participating in any BSC supervised and/or unsupervised activity and using the BSC facilities without injury or impairment of health, and that Parent/Guardian is authorized to execute and deliver this Acknowledgment • Release • Indemnity • Authorization, on behalf of Participant. As such, you understand and voluntarily accept all risk related to, arising from and/or connected with the use of the BSC facilities by yourself, by the Participant, and by your guests and/or invitees. On behalf of yourself, the Participant, and your guests and/or invitees, you agree to follow the rules of conduct and play set by BSC, and acknowledge that the failure to do so may result in suspension from participation in any BSC activity, and expulsion from the BSC facilities.
2. Parent/Guardian, individually, and on behalf of the Participant, your guests and/or invitees, freely and voluntarily releases, waives, discharges, and covenants not to sue BSC, its officers, directors, all associated facilities, its owners, parent and subsidiary corporations, successors, employees, agents, representatives, and assigns, who shall not be liable for any damage whatsoever arising from any personal, bodily or mental injury, economic loss, or property loss sustained by yourself, Participant, and/or your relative, family, invitee, or guest, including injury leading to death, in, related to, arising from and/or connected with, on or about any BSC supervised and/or unsupervised activity, or on or around the BSC premises. Participant and Parent/Guardian assume full responsibility for all such injuries and damages which occur in, on or about any BSC supervised and/or unsupervised activity or use of the BSC facility or any part thereof (“Claims”), including, but not limited to Claims of Parent/Guardian, Participant, and/or the guests or invitees of either, whether caused by the negligence, act or omission by Parent/Guardian, Participant, another participant or spectator, or any other person, including, but not limited to, BSC, its officers, directors, all associated facilities, its owners, parent and subsidiary corporations, representatives, employees, heirs, successors, assigns, and agents.
3. Parent/Guardian shall defend, indemnify and hold BSC, all associated facilities, its owners, parent and subsidiary corporations, successors, employees, heirs, agents, representatives, and assigns, exempt and harmless from any and all claims, damage or injury to any person or property of any person, related to, arising from and/or connected with the observation of or connected with any BSC supervised and/or unsupervised activity, use of the BSC facilities by yourself, the Participant and/or your relative, family, or your guests and/or invitees. Parent/Guardian shall further indemnify, and hold harmless BSC, its officers, directors, all associated facilities, its owners, parent and subsidiary corporations, employees, heirs, successors, assigns, representatives, and agents, from and against any and all claims arising from any breach or default in the performance of any obligation on Parent/Guardian’s part to be performed under the terms of this Acknowledgment • Release • Indemnity • Authorization, and from and against all cost, attorney’s fees, expenses and liabilities incurred in the defense of any such claim or any action or proceeding brought thereon; and in case any action or proceeding be brought against BSC, its officers, directors, all associated facilities, its owners, parent and subsidiary corporations, successors, employees, heirs, agents, representatives, and assigns by reason of any such claim, Parent/Guardian, upon written notice from BSC, shall defend the same at Parent/Guardian’s expense by counsel satisfactory to BSC.
4. Parent/Guardian, individually and on behalf of Participant, do hereby grant authority to the staff at BSC to render a judgment concerning medical assistance or hospital care in the event of an accident or illness occurring in, on or around the BSC facility during my absence.
5. I do hereby authorize BSC, its parent and subsidiary corporations, successors, and assigns, to utilize any and all photographs, pictures or other likeness of me and/or Participant, as they deem appropriate, in their sole discretion, for any purpose including, but not limited to, its promotional materials or team films.
6. If any term, provision, covenant or condition of this Acknowledgment • Release • Indemnity • Authorization shall be held invalid, void, unenforceable, or illegal by a court of competent jurisdiction, the remainder of the terms, provisions, covenants, or conditions of this Acknowledgment • Release • Indemnity • Authorization shall remain in full force and effect and in no way affect, impair or invalidate any other provision hereof.
7. Parent/Guardian, individually and on behalf of Participant, agrees that this Acknowledgment • Release • Indemnity • Authorization is intended to be as broad and inclusive as permitted by law. Parent/Guardian acknowledges that he/she has read the foregoing and that he/she is aware of the legal consequences of this Acknowledgment • Release • Indemnity • Authorization, including, without limitation, that it prevents him/her from suing BSC, all associated facilities, its owners, parent and subsidiary corporations, successors, employees, heirs, agents, representatives, and assigns if Parent/Guardian, Participant, their guests and/or invitees are injured or damaged for any reason, including but not limited to the negligence of BSC, all associated facilities, its owners, parent and subsidiary corporations, successors, employees, heirs, agents, representatives, and assigns, as a result of entering upon or use of the facilities at BSC, its services, equipment or premises, whether as a spectator or participant, guest or invitee, and whether or not a BSC supervised or unsupervised activity is in progress or occurring.
